



KZIA “Bummer Summer Payout” Official Sweepstake Rules

- 1) No purchase is necessary to enter sweepstake and claim prizes.
- 2) **CONTEST DATES:** Bummer Summer begins 12:01 AM on Saturday, July 11th, 2020 and ends at 11:59 PM on Saturday, September 20th, 2020.
- 3) **CONDITION OF PARTICIPATION:** Materials submitted become property of KZIA, Inc. Winner may be required to execute an affidavit of eligibility and name and likeness publicity release and a waiver and release of liability. By participating in this sweepstake, participants agree to be bound by these rules. The decision(s) of judges provided by KZIA, Inc. will be final. All taxes and any registration fees or deposits are the sole responsibility of the verified winner. Payments of all federal, state, and local taxes related to the award of a prize are solely the responsibility of the winner of the prize.
- 4) **ELIGIBILITY:** Participation for the prize is open to any individual, EXCEPT: employees of KZIA, Inc.; persons with a family relationship to those employees (spouse, parent/child, sibling or in-law relationship); owners and or management level employees of advertising agencies in this sweepstake, if applicable; employees of advertising agencies representing sponsors in this sweepstake, if applicable, and employees of the advertising sponsors in this sweepstake, and persons with a family relationship to employees of advertising sponsors in this sweepstake, if applicable. - 5) **AWARDING OF PRIZE(S):** In order to enter the sweepstake, participants must either download the KZIA mobile app (hereinafter “app”) and use the ‘check in’ feature at a participating Bummer Summer event or must place a Z102.9 WinDough sticker (hereinafter “sticker”) on their properly licensed motor vehicle (hereinafter “vehicle”) in a visible location. The mobile app is available to Apple & Android smartphone users at no cost. Stickers are available FREE of charge via mail request or in person during regular business hours at 1110 26th Avenue SW, Cedar Rapids, IA 52404 and at various times are other locations where KZIA is conducting business. Entries may also be submitted via mail by sending name, address, phone, age and e-mail to KZIA Bummer Summer Sweepstakes, 1110 26th Avenue SW, Cedar Rapids, IA 52404. One winner selected at random out of all sweepstake entries on September 20th, 2020 will be awarded the prize. Participants may enter this sweepstake each time they check in to a participating event using the app or with proof of sticker on their vehicle. Participants may only enter once during sweepstake dates if submitting an entry by mail. If the prospective winner meets all other eligibility criteria listed in this document, the participant will be declared a winner. KZIA, Inc is not responsible for technical difficulties, telephone or cell phone service disruptions or other equipment or service issues which might affect the ability of prospective contest participants from participating in this contest.
- 6) **VERIFICATION:** All sweepstake materials are subject to verification. Winners will need to appear in person during regular business hours with their state-issued photographic identification to the KZIA, Inc studios at 1110 26th Avenue SW, Cedar Rapids, IA 52404 in order to claim their prize.
- 7) **PRIZE DESCRIPTION:** The standard prize for this sweepstake is \$500. There will be one winner of this prize. This prize will be issued in the form of a KZIA, Inc check payable to the winner of the sweepstake. Check will be issued within 10 business days of awarding the prize.

- 8) TRANSFER OF PRIZE: Prize is non-transferable and non-exchangeable. No substitution or transfer of prize or cash redemption is permitted.
- 9) LIMITATIONS: The sweepstake participant who is declared a winner in Bummer Summer Payout is no longer eligible to win again in this sweepstake.
