



## **New Pioneer Co-op Facebook Giveaway**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who participate in the designated contest post at [www.facebook.com/z1029](http://www.facebook.com/z1029) and who are 18 as of the date of entry. The Campaign is only open to legal residents of Iowa, United States, and is void where prohibited by law.
