



KZIA Contest Rules

- 1) No purchase is necessary to enter contest and claim prizes.
- 2) **CONTEST DATES: Monday, Jan. 15, 2024, at 6 a.m., to Friday, Jan. 19, 2024, at 10 a.m.**
- 3) **CONDITION OF PARTICIPATION:** Materials submitted become property of KZIA, Inc.
