



## Z102.9's Your Name Cash Game Official Contest Rules

- 1) No purchase is necessary to enter contest and claim prizes.
- 2) **CONTEST DATES:** Z102.9's Your Name Cash Game begins September 16, 2024, and is scheduled to end September 27, 2024. KZIA may choose to extend the game past the scheduled end date. Should the end date be extended, KZIA then reserves the right to end the contest at any time.

Winner may be required to execute an affidavit of eligibility and name and likeness publicity release and a waiver and release of liability.
