



KZIA Contest Rules The Morning Scramble Cash Call

- 1) No purchase is necessary to enter the contest and claim prizes.
- 2) **CONTEST DATES: Wednesday, Oct. 1, 2025, at 12 a.m. to Thursday, Nov. 13, 2025, at 10 a.m.**
- 3) **CONDITION OF PARTICIPATION:** Materials submitted become property of KZIA, Inc. Winner may be required to execute an affidavit of eligibility and name and likeness publicity release and a waiver and release of liability. By participating in this contest, participants agree to be bound by these rules. The decision(s) of judges provided by KZIA, Inc., will be final. All taxes and any registration fees or deposits are the sole responsibility of the verified winner. If the prize includes travel with a traveling companion, the traveling companion must also be age 18 or older and complete the waiver and release of liability form and the name and likeness publicity release.
